5. Obey all laws, and understand that a new arrest may cause this Release Agreement to be revoked.
6. Not depart the State unless authorized by the Court. **\*\*See attached.\*\***

11. If the defendant is on probation, parole or post-prison supervision, contact supervising officer upon release, and obey all conditions of my supervision.

# Definition of Prohibited Contact

## Prohibited contact with a person is defined as:

- ❖ Coming into the visual or physical presence of the person(s).
- ❖ Following the person(s).
- ❖ Waiting or driving by the outside of the home, property, place of work or school of the person(s) or of a member of the person(s) immediate family or household.
- ❖ Sending or making communication with the person(s), including in writing, by telephone, by computer, or in any other form. This includes the use of e-mail, text messaging and communication through web sites.
- ❖ Communicating through a third person with the person(s).
- ❖ Committing a crime against the person(s).
- ❖ Communicating with a third person who has some relationship to the person(s) with the intent of affecting the third person's relationship with the person(s).
- ❖ Damaging the home, property, place of work or school of the person(s).
- ❖ Delivering directly or through a third person any object to the home, property, place of work or school of the person(s).

**ADDITIONAL RELEASE CONDITIONS – 2/5/21**

1. Defendant may reside in the State of Arizona pending further Order of this Court. Defendant must promptly return to the State of Oregon as directed by the Court.
2. Other than Oregon and Arizona, Defendant may not travel to any other State except as necessary for direct travel from Arizona to Oregon or vice-versa.
3. Defendant may not have any excursions when traveling between states.
4. Defendant must promptly notify the Court (through counsel) of any change of address and/or phone numbers.
5. Prior to leaving the State of Oregon, Defendant must submit a signed waiver of extradition.
6. Report directly to pretrial release before 4:00 PM on February 1, 2021.
7. Follow all conditions of the Pretrial Release Office.
8. Defendant shall not possess mace, bear spray or other aerosol repellants.
9. Defendant may not participate in any public demonstrations and shall remain  $\frac{1}{4}$  mile away from any demonstrations taking place.
10. Defendant shall stay two (2) blocks away from the Capitol Mall/Plaza located at 900 State Street, Salem, Oregon.
11. No contact, direct or indirect, with the following individuals:
  - a. Ryan Lyles
  - b. Daniel Sheets
  - c. Duane Meyer; or
  - d. Richard Bratt.

12. Defendant must seek or maintain gainful employment or full-time school/vocational training.

13. Defendant must comply with the conditions of release in Clackamas case no. 20CR49079.
