I, Chandler Pappas, acknowledge that I am currently on pre-trial release authorized by the Marion County Circuit Court. I have requested that I be allowed to live in the State of Arizona pending trial in this case. I understand that my ability to reside outside of the State of Oregon while criminal charges are pending is a privilege and not a right, and that my ability to reside in Arizona is subject to the rules and conditions imposed by the Marion County Circuit Court.

I understand that the previously imposed conditions of release will continue even if I am allowed to reside in the State of Arizona. I agree that I will comply with the terms and conditions of my release that have been placed on me by the Marion County Circuit Court, and further agree to comply with any terms and conditions which may be imposed by the State of Arizona.

I agree to return to the State of Oregon at any time I am directed to by the State of Oregon or the State of Arizona. I know that I may have a constitutional right to insist that the State of Oregon extradite me from the State of Arizona or any other state where I may be found. This is commonly called the right to extradition. But I also understand and acknowledge that I have agreed to return to the State of Oregon when ordered to do so. Therefore, I agree that I will not resist or fight any effort by any state to return me to the State of Oregon during the pendency of these proceedings. I HEREBY AGREE TO WAIVE ANY RIGHT I MAY HAVE TO EXTRADITION. I WAIVE THIS RIGHT


