Defendant’s Motion to Compel came on for hearing on July 30, 2021, before the Honorable Amy M. Baggio. Plaintiff appeared through his attorney, Michael Fuller. Defendant appeared through Deputy City Attorney Caroline Turco. The Court having considered defendant’s Motion to Compel and having been fully advised,

IT IS HEREBY ORDERED that defendant’s Motion to Compel is granted with the following conditions:

1. As to Defendant’s Request for Production (RFP) No. 1: Plaintiff is to provide to Defendant screen shots or either phone contacts or social media contacts for all occurrence witnesses, in Plaintiff’s possession, custody, or control.
2. As to Defendant’s RFP No. 8: Plaintiff is to provide all documents relating to any interaction Plaintiff has had with a Portland Police Officer or other law enforcement officer during a protest, since May 31, 2020, including correspondence, video, photographs, and audio records, in Plaintiff’s possession, custody, or control.
3. As to Defendant’s RFP No. 9: Plaintiff is to provide all documents relating to any

1 protest or march in which Plaintiff was involved in 2020, including correspondence,  
2 video, audio records, photographs, and social media posts, in Plaintiff's possession,  
3 custody, or control.

- 4 4. As to RFP Nos. 8 and 9: The parties will confer after Plaintiff's counsel has had the  
5 opportunity to speak with his client to know what quantity of videos, photographs,  
6 and audio records are responsive to this order. If the quantity is voluminous to the  
7 extent that production is oppressive, Plaintiff will allow Defendant the opportunity to  
8 inspect the discovery.
- 9 5. Discovery items discussed at this hearing are to be provided by or before August 13,  
10 2021, as the Plaintiff's deposition has been noticed for August 19, 2021.
